Prince is anxious to secure & have remitted his said duties, by virtue of said Suretyship, now therefore the deed of trust made the 3rd day of February 1879, between T.W. Prince of our part, John E. Prince Trustee of its second part witnesseth that in consideration of the above premises and one dollar, the said T.W. Prince, does hereby give & convey with general warranty unto the said John E. Prince Trustee, the following real estate to-wit: a certain tract of land situated in Southampton County, containing 100 acres, in the same manner as bounded by the lands of J.W. Leonard, J.W. Turner, the lands formerly owned by Jas C. Bryan, same being land purchased by T.W. Prince of J.E. T. Prince. In trust to secure & have remitted to said J.W. Prince & T.W. Prince from any loss they or either of them may sustain by reason of the Suretyship as aforesaid. And it is hereby agreed that aforesaid creditor of the aforesaid sum shall pay off into or any part or all of the aforesaid bonds, then the said shall secure the payment of such bond or bonds.
