Grant

This Deed made the 18th day of February in the year 1879, between Martha Weston, James Cook and Caroline his wife, Elvick Cobb, and Martha his wife, Frank Weston and Beila his wife, John Glyde and Louisa his wife, and Adaline Weston of the one part, and Phoebe A. Weston of the other part, Witnesseth that at consideration of the being the just proportion of the lands of William Weston dec^d going to said Phoebe A. Weston, as one of his heirs, as the said parties first above mentioned do grant to the said Phoebe A. Weston, all the right, title and interest now have in a certain tract or parcel of land lying in the County of Southampton containing by survey 47^{1/2} acres, and bounded as follows: beginning at a Red oak stump corner on Mariah Drake and Adaline Weston's line, thence north east along a line of marked trees to a sweet gum corner on Elvick Cobb's line, thence along a line of marked trees south east to a poplar corner on Elvick Cobb's line, thence west up the Spring branch to a black gum corner on James Drake and Fatsy Jones' line, thence south west to a point corner on Adaline Weston and Fatsy Jones' line, thence north west to the beginning, and have a grant with special warranty.
