This Deed made this 18th day of February in the year
1799, between Martha Weston James Cobb and
Amaziah his wife, Frank Miller and Delila his
wife, John Glyke and Louisa his wife, Abeline
Weston and Rhody M. Weston of the one part and
Newb Cobb and Martha his wife of the
other part, Witnesseth that in consideration of
its being the just proportion of lands of
the Estate of Wm. Weston dec^d going to said
Martha Cobb as one of his heirs, we the
said parties first above mentioned do grant
to the said Newb Cobb and Martha his wife
all the right title and interest we have
in a certain tract or parcel of land lying
in the County of Southampton, containing
by survey 43^{1/2} acres and bounded as follows
beginning at a Sweet gum corner on Rhody
M. Weston's line thence North East to a Black
gum corner on Mariab Drake's line, thence
Back along the Landford's branch to a water
corner on Louisa Conwell's line, thence
South East along said Branch to a poplar
corner on Rhody M. Weston's land, thence South
West to the beginning, and this we grant
