*Deed.* This Deed, made the 1<sup>st</sup> day of May in the  
 year 1879 between Richard H. B. Cobb of the one  
 part & Luther R. Edwards of the other part, in  
 Town of Franklin; that the said Richard H. B. Cobb doth  
 grant unto the said Luther R. Edwards the  
 following property: a certain tract of land  
 Lot of Land situated in the Town of Franklin  
 & designated on the map of Franklin as Lot  
 No 63 bounded as follows; Commencing at  
 the intersection of Main Street with Fourth  
 Avenue, on the north side of 4th Avenue & on  
 the west side of main Street, thence along  
 main Street in a northerly direction 210 feet  
 to 5<sup>th</sup> Avenue, thence along 5<sup>th</sup> Avenue in  
 a northerly direction to the Land belonging  
 to Mary W. Sarah A. Julia C. S. P. & J. D. Prich-  
 ards along the line of the said M. W. S. A. C. S.  
 P. & J. D. Prichards in a southerly & westerly direc-  
 tion to a point on the said Prichards line from  
 which point a straight line when drawn per-  
 pendicular to Main Street & parallel with  
 4<sup>th</sup> Avenue will measure 57 $\frac{1}{4}$  feet, thence  
 along a straight line in a southerly di-  
 rection from said point on said Prichards line  
 parallel with main Street & about 207 $\frac{1}{4}$  feet  
 to 4<sup>th</sup> Avenue, thence along 4<sup>th</sup> Avenue in an  
 easterly direction 87 $\frac{1}{4}$  feet to the point of begin-  
 ning estimated to contain a little more than  
 one fourth acre in trust to secure the fol-  
 lowing debt to wit: one bond bearing due date  
 with this deed, and given for purchase price of  
 lot herein conveyed, for three hundred and twenty  
 five dollars, and due unto John Prichard Jr.  
 or his assigns, and should the said R. H. B. Cobb make  
 default in payment of said bond when payment  
 is demanded then the said trustee shall after  
 giving 10 days notice, sell said lot of land  
 for cash, and after deducting from proceeds  
 of said sale all legal expenses together with  
 five per centum as said sale for sole trustee,  
 and also the amount of said bond, he shall  
 pay the remainder of said proceeds to said R. H.
