This Deed made the 3 day of October 1900 between Mr. H. H. Nord trustee, party of the first part, James
 Mc Barrett of the second part, and Franklin Vick of the third part, Whereas, by deed dated
 the 6th day of December in the year 1877 and of record in the Clerk's Office of the County of
 Southampton, the said James Mc Barrett in order to secure to the said Franklin Vick the pay-
 ment of a certain bond executed by said James Mc Barrett and payable to the said Franklin
 Vick bearing date the 8 day of December 1877 and for the payment of the sum of one hundred
 and seventy five and 7/10 dollars on the 3 day of December 1900 did convey in trust to the said
 Mr. H. H. Nord certain property, part of and described in said deed as follows, that is to say, a
 certain tract or parcel of land lying and being in the County of Southampton, known both
 as the Jones tract, situated on the Crozer's road and bounded on the north by R. R. Davis on the
 east by Geo. B. Davis south by A. S. Abbeville on the south by R. W. Branch, containing fifty acres
 more or less, being the same tract this day conveyed by Mr. H. H. Nord trustee to said James Mc Barrett
 and whereas the said bond has been fully paid, and the said James Mc Barrett desires the said
 property to be released to him, and therefore this deed is in full satisfaction of the said bond
 and as aforesaid, in consideration of the premises and by and with the consent of the said
 Franklin Vick Testified to by his becoming a party to this deed and signing and sealing
 the same, doth grant and release unto the said James Mc Barrett all that certain tract of land
 above described and known as the Jones tract, the said Franklin Vick hereby assigns
 to the said James Mc Barrett all his claims upon said lands,
