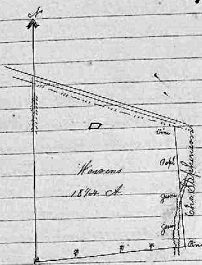


Exemnd.

This Deed, made this 10th day of January, Eighteen hundred and eighty one between Saml B. Kells and Virginia B. Kells heirs of the first part and Jerry P. Murren of the second part all of the County of Southampton Virginia, Testifyeth, that, in consideration of the sum of \$500⁰⁰ fifty dollars, the said Saml B. Kells and Virginia B. Kells his heirs do grant unto the said Jerry P. Murren with good and lawful warranty, all of a certain piece or parcel of land situate in said County, and bounded as herein described, commencing in this exact thence Southly along Chappell line (Ed. Gab. Long) to White Oak Cove thence Southly along Chappell line to Pine Cove on the Edgumson line thence Northly along branch and Chappell line to C. B. in the said thence along this road to the commencement containing 18 1/4 acres more or less. The said Saml B. Kells and Virginia B. Kells his wife covenant that they have the right to convey the said lands to the grantee that they have done so act to encumber the said land, and that the grantee shall have quiet possession of said land free from all incumbrance, and that they parties of the first part will execute such further assurance of the said land as may be required.
