Whitley by Charles Whitley & Lucille Whitley his wife by last living date Jan^y 15th 1881 it being the land known as Bathurst Whitley place bounded to contain one hundred and twenty seven and a half acres, more or less and bounded by the lands of R. C. Barrett & Lucille Barrett Mrs. Sarah J. Barrett half Conitt and others In trust however to secure the payment of the following notes due & payable to J. H. Whitley six hundred dollars with interest from the said date per common and the principal of paying the principal five years after date.

This Deed made this 10th day of January in the year one thousand eight hundred and eight, one Between Jethro Bell of the County of Southampton State of Virginia of the first part, and Elbert Bell of the same place of the second part, Witnesseth that the said Jethro Bell of the first part for and in consideration of the sum of six hundred dollars to him in hand paid by the said Elbert Bell which he has acknowledged and sold and by their presents both hereunto and sold, conveyed and confirmed unto the said Jethro Bell of the second part his heirs and assigns, all that piece or pieces of land situated in the County of Southampton State of Virginia and bounded on the north by the lands of Jethro Bell on the east by Black Water river on the east by Cypress Swamp on the west by County road to Cherry Grove Ferry more particularly described as follows: Beginning at a post on the road leading from Cherry Grove Ferry to Cherry Grove Ferry and of 100 ft. being by various courses of said lot in 60.94 chains from Southwary road, then 100 ft.
