This Deed of Bargain & Sale made this the 29th day of November 1830 between Bartlett Tomlinson and Annis his wife, of the Province of South Carolina Parker & Luther R. Edwards of the State of Virginia, County of Southampton grantors, of the first part and John Britton Jr of the said County of Southampton State of Virginia grantees, of the second part. Witnesseth: That whereas the said Bartlett Tomlinson did in the year 1819 by deed of Bargain & Sale purchase from the said Gideon Parker a certain parcel or tract of land lying and situated in the said County of Southampton State of Virginia and in order to secure an unpaid balance of the purchase price of said land the said Tomlinson did convey unto the said Luther R. Edwards Trustee, the said tract of land in trust to secure the said unpaid balance of said purchase price, and whereas the said unpaid balance of purchase price has been now fully paid: Now therefore in consideration of the payment of the sum of Four thousand seven hundred and fifty dollars to him paid by the said grantee (John Britton Jr) they the said Bartlett Tomlinson and Annis his wife do grant, convey bargain & sell with general warranty, and in further consideration of the premium, the said Gideon Parker and Luther R. Edwards Trustee do with special covenancy grant bargain & sell all of their right title and interest in the above mentioned tract of land bought by the said Tomlinson from the said Parker, and bounded as follows by the lands of Betty & Rosa both James Vaughan Fathers on the North, East & South and by the Pottery river on the west and containing nine hundred and nineteen $\frac{3}{4}$ acres more or less. Reference is hereby made to the deed of Bargain & Sale from the said Gideon Parker to the said Bartlett Tomlinson for a more accurate description of this land. This sale by said Tomlinson is subject to an unrecorded contract between him and Anthony Vaughan in regard to the purchase of a part of said land, but the said Tomlinson conveys unto the said Britton all rights, equities and interest which he the said Tomlinson has or may have in said land contracted for, by the said Anthony Vaughan, and hereby impowers the said Britton to possess himself of said land according to the terms of said contract if said Vaughan shall fail to comply with the provisions of said contract, and the said Bartlett Tomlinson and Annis his wife command to make any further conveyance necessary to convey unto the said Britton and undivided title to said land together with all improvements appurtenances, rights, covenants and profits by the same belonging, Witness the following signatures and seals
