Johnson and Hester A. his wife, for and in consideration of the sum of One thousand Six hundred and fifty Dollars to them in hand by the said R. J. W. M. Kelly at an before the delivery of these presents the receipt whereof is hereby acknowledged have granted bargained and sold and by these presents do grant and sell each of them cloth grant bargain and sell to the said R. J. W. M. Kelly their heirs and assigns forever one certain tract or parcel of land situated lying and being in the County of Southampton and State of Virginia containing two hundred and ninety six acres more or less and bounded by the lands of the heirs of Oliver Johnson decd the heirs of Wilson Darden decd the heirs Leonard Leet decd J. E. Warren and the heirs of Am. Battle thys the said J. E. Johnson and Hester A. his wife conveying the said two hundred and ninety six acres of land to have and to hold the above described tract or parcel of land and promises with all and singular its appurtenances thys herein purgente them the said R. J. W. M. Kelly their heirs and assigns forever and the said J. E. Johnson and Hester A. his wife for themselves their heirs executors and administrators do and each of them cloth hereby covenant and agree to and with the said R. J. W. M. Kelly their heirs and assigns that they will by these presents warrant and forever defend all the right and title of the aforesaid tract or parcel of land and promises hereby conveyed against the claims, demands of all and every other person or persons whatsoever in witness whereof the said J. E. Johnson and Hester A. his wife have hereunto set their hands and affixed
