This Deed made ^{this} 11th day of March Eighteen hundred and Eighty one between Joseph J Harris and Sarah E Harris his wife of the first part and Jacobiah Doyl trustee of the second part, Witnesseth that the said Joseph J Harris and Sarah E his wife doth grant bargain & convey unto the said Jacobiah Doyl trustee a tract of land in the County of Southampton containing 157 acres more or less and adjoining the Land of Jacobiah Doyl Josephus Harris and others it being a part of the lands formerly belonging to Eliza Harris in trust to secure a debt of Eliza J before and Christiania Harris acknowledged by bonds to Eliza J before for the sum of two hundred Eighty two Dollars and 15^{cts} bearing date the 2nd day of March 1881 and Doyl to Christiania Harris for two hundred Eighty two Dollars & 49^{cts} bearing date the 2nd day of March 1881 the said bonds to secure a proviso of all amounts from sale of said above named land and it is hereby covenanted and agreed by the said Joseph J Harris and Sarah E his wife to grant and deliver unto said Jacobiah Doyl trustee the above named land for the payment of the above named debts,
