This Argument entered into this the day of 1831 between Joshua H. Powell of one part and Waverly Wood and William Sykes and Alex Green of the other parties, all the parties of Southampten Co and State of Va. Witness that whereas the said Parties is about to engage in the cultivation of the Lands owned by the said Jos H Powell and is desirous to obtain during the year 1831 Supplies in sup^{pl}ies from the said Jos H Powell to the amt of Three hundred Dollars below them one hundred Dollars a piece beyond which limit the said Parties shall not go and the said Jos H Powell having agreed on his part to furnish to the said advance as more the said parties on their parts in consideration of the above promises do hereby grant a lien to the said Jos H Powell upon all crops that may be made on the Lands cultivated by the said parties during the year 1831. The said parties further agree to deliver to the said Jos H Powell all Cotton & other produce made on said lands during the year 1831. At any place the said Powell may direct. To have and to hold until all claims be settled that the said Jos H Powell may hold against the said parties and after all claims be settled balance of said proceeds is to be paid unto the said parties. The said parties further agree that said lands shall be worked in good order and if not the said Jos H Powell is to hire hands and have it worked and charge or expense of said hands to the said parties, this lien is granted under an act of the general assembly of Virginia approved April 24th 1813 Entitled an act to secure Advances for agricultural purposes. This Argument entered into this 10th day of March 1831 between Jas J Darden & Co. No Darden agt of the first part and Augustus Aris of the other part to the effect as follows. That whereas the said Augustus Aris is about to engage in the cultivation of the soil and is desirous to obtain sup^{pl}ies during the year 1831 from the said Jas J Darden & Co. No Darden agt for the amount of Fifty Dollars and for taking the acknowledgment and for recording this agreement, and the said Jas J Darden having on his part agreed to furnish said sup^{pl}ies. Now the said Augustus Aris on his part and in consideration of the above promises do hereby grant a lien to the said Jas J Darden on his crops of all kinds to be made on the Hot Run the year 1831 and I hereby assign my emptions as to this contract. For the amount advanced him this year which has been intended to have been repaid and the said Aris binds himself payable to Jas J Darden & Co. No Darden on crops above mentioned to Jas J Darden, at Newmans Depot Va by or before the 14th day of Novr 1831. This lien is granted under an act of the general assembly of Virginia approved April 24th 1813 Entitled an act
