Norrell, Matilda Norrell and Catharine Norrell are engaged in the cultivation of the soil, and are desirous to obtain during the year 1881 advances in supplies from the said W. M. Beaton, to the amount of one hundred and eighty five dollars, beyond which limit the said James H. Norrell, Matilda Norrell and Catharine Norrell shall not go, and the said W. M. Beaton, having on his part agreed to furnish said amount in supplies, Now the said James H. Norrell, Matilda Norrell and Catharine Norrell on their part in consideration of the above promises do hereby grant a lien to the said W. M. Beaton on the Crops of every kind so much may be made during the year 1881, upon the lands in cultivation of which the above amount of advances has been or will be expended to have same repaid, this Lien is granted under an Act of the General Assembly of Virginia, Approved April 23rd 1879, Entitled An Act to secure Advances for Agricultural Purposes.
