This Deed of Trust made this 23<sup>rd</sup> day of March 1881 between Henry B Lindred of the  
one part and Joseph B Pope Trustee of the other, both of the County of Southampton and  
State of Virginia. Witnesseth That for the consideration of Two Dollars in hand paid by  
the said Joseph B Pope to the said Henry B Lindred receipt of which is hereby acknowledged,  
the said Lindred doth grant and Convey and by these presents doth give quit claim  
unto the said Pope the following tract of land known as the Lindred home place,  
containing Two Hundred acres more or less, the said Lindred doth also grant unto  
the said Pope Two Hundred and Fifty Acres of ground at present culti and prepared  
on the above land herein conveyed, said land and soal are conveyed hereto to  
secure an certain bond of iron date with this Deed for Three Thousand dollars Due and  
payable to J E Bailey beneficiary of this Deed, and it is agreed by the parties  
to this Deed that should a sale take place, there shall be given 20 days notice of time and  
place and the trustee shall be entitled to set an open sale. Witness the following signatures  
and seals this day and date of forenoon,
