Whereas Jesse Parker of the County of Southampton, State of Virginia is engaged in the cultivation of the soil for the year ending Dec 31st 1881 in and upon a certain tract or parcel of land lying in the County of Southampton, No is in the occupancy of W. McNeill & Jno Castles Jr and adjacent to the lands of W. H. Vaghecat, J. W. McKinnis & Co and Robert B. Smith of Southampton County has agreed to advance to the said Jesse Parker a loan not to exceed in the whole one hundred Dollars which money is intended to be expended in the cultivation of the said tract or parcel of land for which sum as advanced by the said Robert B. Smith he is to be entitled to a lien according to law on the crops which may be made by the said Jesse Parker on the said tract or parcel of land during the year aforesaid. Now this deed made between the said Robert B. Smith of the one part and the said Jesse Parker of the other part witnesseth that it is agreed between the said parties that the said Robert B. Smith shall make advances to the said Jesse Parker of an amount not exceeding in the whole the sum of One hundred Dollars which is intended to be expended in the cultivation of the tract or parcel of land aforesaid, and which the said Jesse Parker for himself & his heirs agreed to repay to the said Robert B. Smith as he assigns on or before the 30th day of Nov. A.D. 1881 with lawful interest on the aforesaid advances from the time when they were respectively made until payment, and it is further agreed by and between the said parties that the said Robert B. Smith shall be entitled to a lien according to the statute in that case made & provided to the extent of the advances which he shall make as aforesaid to the said Jesse Parker on all the crops which may be made by the said Jesse Parker on the said tract or parcel of land during the year aforesaid, ending on the 31st day of Dec. This Agreement made this 14th day of March in the year 1881 between W. B. Applichite of the first part and Barham Pinner of the other part, both of the County of Southampton, State of Virginia Witnesseth as follows. Whereas the said W. B. Applichite is engaged in or is about to engage in the cultivation of the soil, and it is desired that the said Barham Pinner shall during the present year make certain advances to the said cultivator of the soil, which the said Barham Pinner has agreed to do. Now this Agreement witnesseth that the said Barham Pinner does hereby promise and agree to advance and furnish to the said W. B. Applichite during the present year such money provisions fertilizers and other supplies for the sum of Three thousand pounds said cotton first picking in amount as may be needed to enable the said W. B. Applichite to cultivate and gather his crops proposed to be made in the present year. And the said W. B. Applichite hereby gives and grants to the said Barham Pinner a lien upon Three thousand pounds of seed cotton as he may make the present year to secure the payment for all such supplies and advances as may be actually made not exceeding the amount above stated. This agreement is made in pursuance of an act of the General Assembly of Virginia approved April 3rd 1881.
