This Agreement made and entered into this 2nd day of April 1881 between Wm. A. Maysick of the first part and R. P. Pope of the other part witnesses that as follows: that whereas the said R. P. Pope is about to engage in the cultivation of the soil and is desirous to obtain supplies from the said Wm. A. Maysick during the year 1881 for the amount of Five Hundred and Seventy Five Dollars and Sixty Five Cents for the amount of Five Hundred and Seventy Five Dollars and Sixty Five Cents of clean white lint cotton of first picking to be delivered on or before November first 1881, and by and to which amount the said Wm. A. Maysick has agreed to advance to the said R. P. Pope on his part and in consideration of the above provisions to be duly granted a loan to the said Wm. A. Maysick an all the crops which may be made during the year 1881 upon the lands of which the said R. P. Pope cultivates or has cultivated for the above amount of advances, which has been or was intended to be so advanced, Now it is further agreed by the parties to this agreement, that the said Wm. A. Maysick shall be first paid and satisfied, after which the balance if any shall be paid over to the said R. P. Pope. This deed is guaranteed under an act of the general assembly of Virginia approved April 2nd 1873 entitled an act to secure the advances for agricultural purposes, with the foregoing signatures and seals.
