This Agreement made this 13th day of April in the year 1881, between John
Mason of the first part, and Barham & Runner of the other part, both of the
County of Southampton State of Virginia, Witness as follows: Whereas the
said John Mason is engaged in, and about to engage in the cultivation of the soil and
is desirous that the said Barham & Runner should during the present year make
certain advances to the said cultivator of the soil, which the said Barham & Runner
have agreed to do. Now this Agreement witnesseth, that the said Barham & Runner
do hereby promise and agree to advance and furnish to the said John
Mason during the present year such monies, provisions, fuel, grain and other
supplies (not exceeding the sum of fifty dollars doct^r in an account) as may
be useful to enable the said John Mason to cultivate and gather his crops
proposed to be made the present year. And the said John Mason hereby gives
and grants to the said Barham & Runner a lien upon all such crops as
he may make the present year to wit, Corn, Potatoes, Peas, Beans, Cotton and
all other crops in order to secure the payment for all such supplies and
advances as may be actually made, not exceeding the sum above stated.
This lien is made in pursuance of an Act of the General Assembly of Virginia,
approved April 2, 1873. Witness our hands this 13th day of April 1881.
