This Agreement made this 5<sup>th</sup> day of April in the year 1881 between Mr Colbert  
of the first part and John I Turner of the other part both of the County of  
Southampton State of Virginia. Whereas the said Mr  
Colbert is engaged in agriculture in the cultivation of the soil, and it  
desirous that the said John I Turner shall during the present year make certain  
advances to the said cultivator of the soil which the said John I Turner has agreed  
to do. Now this Agreement is made that the said John I Turner do hereby  
promise and agrees to advance and furnish to the said Mr Colbert during the  
present year such monies, provisions, fertilizers and other supplies (not exceeding  
the sum of 100 one hundred dollars in amount) as may be useful to enable the  
said Mr Colbert to cultivate and gather his crops products to be used the  
present year. And the said Mr Colbert hereby gives and grants to the said John  
I Turner a lien upon all such crops as he may raise the present year  
to soil, Corn, Peas, Peanuts, Cotton and all other crops in addition to receive  
the payment for all such supplies and advances as may be actually made  
not exceeding the sum above stated. This Agreement is made in furtherance of  
an act of the General Assembly of Virginia approved April 2 1879.  
Witness our hands at this 5<sup>th</sup> day of April 1881.

it is for ever. Whereas the said Walker & Old is engaged in agriculture  
in the cultivation of the soil, and it is desirous that the said  
Barham I Turner shall during the present year make certain advances  
to the said cultivator of the soil which the said Barham I Turner has  
agreed to do. Now this Agreement is made that the said Barham  
I Turner do hereby promise and agree to advance and furnish to  
the said Walker & Old during the present year such monies, provisions,  
fertilizers and other supplies (not exceeding the sum of twenty five dollars in  
amount) as may be useful to enable the said Walker & Old to cultivate
