This Agreement made this 22nd day of Feb in the year 1881 between R. B. Davis of the first part and Barham D. Turner of the other part both of the County of Southampton and State of Virginia contains these following: Whereas the said R. B. Davis is engaged or is about to engage in the cultivation of the soil and is desirous that the said Barham D. Turner shall during the present year make certain advances to the said cultivator of the soil and which the said Barham D. Turner has agreed to do. Now their agreement contains with that the said Barham D. Turner does hereby promise and agree to advance and furnish to the said R. B. Davis during the present year such money, provision, fertilizer and other supplies not exceeding the sum of one hundred and fifty dollars in amount as may be needful to enable the said R. B. Davis to cultivate and gather his crops provided to be made the present year and the said R. B. Davis hereby gives and grants to the said Barham D. Turner a lien upon all such crops as he may make the present year to wit: Corn, Potatoes, Peas, Turneps, Cotton and all other crops in order to secure the payment for all such supplies with advances as may be actually made not exceeding the sum above stated. This agreement is made in pursuance of an Act of the General Assembly of Virginia approved April 2nd 1873, contains as hereto this 22nd day of Feb 1881.

This Agreement made this 14th day of May in the year 1881 between J. P. Blewett of the first part and Stephen Brown of the other part both of the County of Southampton State of Virginia. Witnesseth as follows: Whereas the said Stephen Brown is engaged or is about to engage in the cultivation of the soil and is desirous that the said J. P. Blewett shall during the present year make certain advances to the said cultivator of the soil which the said J. P. Blewett has agreed to do. Now their agreement contains with that the said J. P. Blewett does hereby promise and agree to advance and furnish to the said Stephen Brown during the present year such money, provision, fertilizer and other supplies (not exceeding the sum of twenty five dollars in amount) as may be needful to enable the said Stephen Brown to cultivate and gather his crops provided to be made the present year and the said Stephen Brown hereby gives and grants to the said J. P. Blewett a lien upon all such crops as he may make the present year to wit: Corn, Potatoes, Peas, Turneps, Cotton and all other crops in order to secure the
