This Deed made this 19<sup>th</sup> day of May 1881 between Jessie A. Moore and  
James W. Moore the husband of said Jessie A. Moore of the County of  
Southampton State of Virginia of the first part grantor and R. H.  
B. & J. Morris Abbott herein the style of R. H. B. Cobb & Co. of said County  
and State of the second part grantee witness that in consider-  
ation of the sum of Five hundred and fifty dollars to them in hand  
paid by said grantee, they the said grantors hereby receipting for the  
sum and granting, conveying, bargaining and selling with general  
covenant unto the said grantees the following real property to wit: a  
certain parcel or lot of land in the said County of Southampton and  
bounded as follows: to wit, commencing at the east side of main  
street at its conct with the southw. boundary of Frank Holland's  
stone house lot on the south side of 1<sup>st</sup> Avenue in the town of Franklin,  
thence in an easterly direction along said street so as to run line  
310 feet to Mrs. W. A. Butler's line, thence in a southerly direction along  
said Mrs. Butler's line 31 feet 1/4 inch, thence in a westerly direction  
along the supposed middle of a lot sold by W. H. Morris & Co. with  
Jessie A. Moore one of which lot the lot hereby conveyed is a part  
210 feet to inclose it, thence along main street in a northerly
