This Deed made this third day of June in the year 1881 between Jno H Griffin of the first part and R R Kitchen trustee of the second part both of the County of Southampton and State of Virginia Witnesses that for and in consideration of the sum of Five dollars to him in hand paid the receipt whereof is hereby acknowledged by the said party of the first part doth grant sell and convey unto the said party of the second part all of his Cashmere growing on the farm on which he lived consisting of Corn Cotton and pecanets all of his farming implements consisting of hoes harness hoes &c also one bay mare seven years and one cow to have and to hold the aforesaid Cashmere implements hoes and cows to him the said R R Kitchen trustee his heirs and assigns forever In test hereunto to secure to Messrs Etheridge and Brooks of the City of Portsmouth the payment of one bond for the sum of \$12.75 bearing date on the 3rd day of June 1881 and negotiable and payable at the Office of the said Etheridge & Brooks in the City of Portsmouth eight months after date Witness the following signatures and seal the day and year above written.
