This Agreement made and entered into this 17th day of May 1881 between Mrs. A. M. Myrick of the first part and R. D. Gray of the other part, with intent as follows: That whereas the said R. D. Gray is about to engage in the cultivation of the soil and is desirous to obtain supplies during the year 1881 from the said Mrs. A. and Mrs. E. Myrick for the sum of Two Hundred Dollars, beyond which amount the said R. D. Gray shall not go and the said Mrs. A. and Mrs. E. Myrick having on their part agreed to furnish said supplies more the said R. D. Gray ask his part and in consideration of the above provisions doth grant claim to the said Mrs. A. and Mrs. E. Myrick an act the crops which may be made during the year 1881 upon the lands of which the said R. D. Gray cultivates for the above amount of advance which has been an over intended to have been expended. Now it is further agreed by the parties to this agreement that the said Mrs. A. and Mrs. E. Myrick shall be first paid and satisfied after which the balance if any shall be paid over to the said R. D. Gray. This Lien is granted under an act of the general Assembly of Virginia of 1870 April 2nd 1873 entitled an act to secure the advances for agricultural purposes, witness the following signatures and seals
