This Deed of Bargain & Sale made this the 7th day of March 1881 betwixt
 S. C. Scott and Sarah E. Scott his wife, George W. Scott and Virginia H. Scott his
 wife of the first part grantors and James W. and John C. Council of
 the second part grantees witnesseth that in consideration of the sum
 of one hundred and fifty dollars the receipt whereof is hereby acknowledged
 to them in hand paid by the said grantors, they the said
 grantors do grant, convey, bargain & sell with general warranty unto
 the said grantees the following real property to wit all of the said
 grantors interest in the certain parcel or lot of land lying in the
 County of Southampton State of Virginia and bounded as follows
 to wit on the north by the land of Geo. W. Scott tract, on the east
 by the land of Harrison Scott (deceased) on the south by the land of
 said S. C. Scott and James W. and John C. Council on the west by the land
 of Geo. W. and Virginia H. Scott, containing by estimation one hundred
 forty three and 1/2 acres more or less, it being the land belonging to the estate
 of Geo. W. Council deceased, the interest conveyed in said land is 7/8
 of said real property which is still unpaid, and the said grantees
 covenant that they have the right to make this conveyance and that they
 will make any further assurances necessary to carry into effect said
 grantors an undisputed title to said and undivided 7/8 interest in said
 real property, together with all rights, easements and appurtenances
 thereunto belonging (all of the said grantors interest in case intended
