This Indenture made the 18th day of Dec. in the Year of our Lord one thousand seven
 hundred & sixty six Between W^m Bull & Martha his wife of the County of Southampton
 of the one part & Simon Johnson & Giles Johnson of the same County of the other part
 Witnesseth that the said W^m Bull & Martha Bull his wife for in consideration
 of the sum of twelve pounds current money of Virginia do them in hand paid by the
 said Simon Johnson & Giles Johnson before the sealing and delivery hereof the
 receipt whereof the said W^m Bull & Martha Bull his wife doth hereby acknowledge
 they hath granted & sold & do hereby their presents grant bargain & sell unto
 the said Simon Johnson & Giles Johnson to their heirs & assigns forever a cer-
 tain tract or parcel of land lying & being in the County aforesaid containing
 one hundred & thirty seven acres more or less part of a patent for five hundred
 & sixty five acres of land granted to Joseph Goorin the 25th day of July 1746
 by the said Joseph Goorin sold & conveyed to John Brown & by the said John
 Brown sold & conveyed to W^m Bull & by the said W^m Bull & Martha Bull
 his wife hath sold & conveyed to Simon Johnson & Giles Johnson & bounded
 as followeth (to wit) Beginning at a maple on the long branch then down
 the said branch to Barnaby McQuinnys line then up the said McQuinnys
 line to a pine then a line of marked trees to the Beginning of the reversion &
 reversions remainder & remainder with issues & profits thereof of all the estate
 right title interest claim & demand whatsoever of him the said W^m Bull
 & Martha Bull his wife their heirs of in or to the same or any part thereof
 To have & to hold the said land & premises with the appurtenances unto the
 said Simon Johnson & Giles Johnson their heirs & assigns forever to the only proper
 use & behoof of the said Simon Johnson & Giles Johnson their heirs & assigns
 forever & the said W^m Bull & Martha Bull his wife & their heirs the said
 land & premises with the appurtenances to the said Simon Johnson &
 Giles Johnson their heirs & assigns shall & will warrant & forever defend
 by their presents in witness whereof the said W^m Bull & Martha Bull
 his wife hath hereunto set their hands & seals the day & Year above written
