This Indenture made this twelfth day of April in the tenth Year of the reign
 of our sovereign lord George the third King of Great Britain France & Ireland
 in the Year of our lord Christ one thousand seven hundred & seventy between
 Jesse Jones of Southampton county of the one part & Britain Jones of the County of
 the other part Witnesseth that the said Jesse Jones for and in consideration of
 the sum of twenty pounds current money of Virginia to him in hand paid by the
 said Britain Jones at & before the enrolling & delivery of these presents the receipt
 whereof the said Jesse Jones doth hereby acknowledge & thereof both acquit the said
 Jones his heirs executors and administrators hath granted bargain sold alien
 & confirmed and made over & by these presents doth grant bargain sell
 alien enfeoff confirm & made over unto Britain Jones his heirs executors
 & assigns for ever one certain tract or parcel of land containing by estimate
 one hundred & fifty acres lying & being on the South side of Flat Swamp in
 said County & bounded as followeth to wit Beginning at a white oak corner
 one of the said Britain Jones by the side of the Flat Swamp thence south
 forty one degrees east eighty poles to a white oak thence south eighty degrees east
 thirty two poles to a white oak thence south twenty three degrees east sixty
 poles to a white oak thence North eighty degrees east one hundred & eighty poles
 the line of the aforesaid swamp & up the various courses of the run of the said
 swamp to the Beginning of the reversion & reversions remain & remain
 of & singular the premises with the appurtenances & all the estate
 right with possession claim & dem and whatsoever of them the said Jesse
