alias Stewart of Johnston county of North Carolina of the one part & James Bullard  
of Southampton county of Virginia of the other part witnesseth that the said  
William Davis alias Stewart for and in consideration of the sum of thirty  
pounds current money of Virginia to him in hand paid by the said James Bullard  
before the sealing and delivering these presents the receipt whereof the said Davis  
alias Stewart doth hereby acknowledge hath granted bargained & sold by these  
presents doth grant bargain & sell unto the said James Bullard his heirs and  
assigns forever a certain tract or parcel of land lying and being in the said  
county of Southampton containing by estimation one hundred & seventy five acres  
to the same more or less the said land being the land that John Davis (who  
departed this life some years ago) bequeathed in his last will & testament  
to his son William Davis (or rather William Davis alias Stewart) bounded  
as followeth to wit on the north side of the Three Creeks on the Bloody Branch and  
between the lands of Thomas McCoa Pamela Biley John Wiggins & W. Lemore
