

Confirmation unto the said Amos Harris on certain tract or parcel of Land situated
 lying being in the County of Southampton aforesaid on the south side of a slow way
 Branch and Bounded as followeth to wit Beginning at Black oak at the head of George
 Branch near the well thence North fifty Degrees East twenty eight poles to a dead oak thence
 South twenty Degrees East one Hundred & twenty poles to a pine by the side of the fork
 Branch then down the various courses of the said Branch to a line of marked trees
 (Bounded to by the Patentee of the said Land to be made) near a South course to
 a line of marked trees (agreed to be made as aforesaid) to the head of the said Branch then along a
 the said George Branch to the head of the well pond or Beginning containing as is
 Inonaginta by the persons that made the said dividing line) one hundred & fifty
 acres be the same more or less (it being the part of seven Hundred & forty Acres granted
 to Henry Row by Letters patent bearing date the tenth day of February one thousand
 seven hundred & forty eight & the said Acres was conveyed from the said Row to
 W^m Johnson, from the said Johnson to Joseph Matthews from the said Matthews to
 John Brewer, from the said Brewer to the said W^m Kemp and also all Houses
 Lands ways waters water courses, Commodities advantages hereafterments
 appurtenances whatsoever to the said tract or parcel of Land belonging or
 in anywise pertaining, & also the Reversion & Reversions Remainders
 and Remainders, rents & services of all and singular premises & every part & parcel
 thereof also all the Estate, Right title Interest property claim & demand
 whatsoever of him the said W^m Kemp of in or to the same. To have
 & to hold the said tract or parcel of Land and Premises with the appurtenances
 unto the said Amos Harris his heirs and assigns forever & the the said W^m Kemp
 the said tract or parcel of Land to the said Amos Harris his heirs assigns
 that is to say the said W^m Kemp the said tract or parcel of Land and
 premises, to the said Amos Harris his heirs and assigns against him
 the said W^m Kemp & his heirs & against all other persons shall
 & will warrant & forever defend to the said Amos Harris his
 heirs & assigns forever by these Presents In witness whereof the
