

Money stocks of Cattle horses hogs sheep & other personal & chattels which if
the said marriage take effect to the said Thomas Lane will be entitled to the possession
of & property in, & to the land that such lands slaves & estate of & interest thereof
may be hereafter disposed of & settled according to the agreement of trusts as this
indenture is prepared. This Indenture witnesseth that as well in consideration
of the said agreement & the said intended marriage as also for & in consideration of
the sum of five shillings current money of Virginia to her the said Lucy
Jones in hand paid by the said Jesse Jones as or before the executing of delivery
of these presents the receipt whereof is hereby acknowledged & for divers other
good causes & considerations between the said Lucy Jones & her heirs & assigns
by & with the private knowledge consent and agreement of him the said
Thomas Lane & testified by his being made a party to the signing & sealing these
presents granted bargained sold assigned & made over & by these presents doth
grant bargain sell assign & make over unto the said Jesse Jones & his heirs
situate in the aforesaid parish of St. Andrew & county of Southampton where
on she the said Lucy Jones now dwelleth containing three hundred & thirty acres
be the same more or less which descended to the said Lucy on the death of her father
Joseph Jones deceased with one strong water still & its appurtenances annexed
to the said land together with these following negro slaves & their future
increase to wit Sam Deek Will Samuel Jacob Frank & Tab. & also the sum
of one hundred pounds as in specie To hold to the said Jesse Jones and to
his heirs & assigns forever Upon this special trust & confidence never
to be sold & the intent & purpose herein after Limited expressed and
declared that is to say that the said Jesse Jones his heirs or assigns
shall not dispose of the aforesaid lands slaves & money hereby conveyed
to such person & persons to such uses only & in such manner as
the said Lucy Jones either by deed her last will & testament or
other ways may direct & appoint whether she be sole or married &
that the said Jesse Jones his heirs or assigns shall not dispose of
employ or pay the same to any other person or person or to any
other uses or by any other appointment whatsoever & from time
to time until such appointment shall be made by the said
Lucy Jones it shall be lawful for the said Thomas Lane to hold
use occupy & enjoy the aforesaid lands slaves still & money
hereby intended to be secured & conveyed to the said Thomas Lane for
himself his heirs executors & administration doth covenant
promise & agree to & with the said Jesse Jones his heirs & assigns
in manner & from following that is to say that she the said Lucy
Jones shall in all time hereafter as well during the said limited
cover time as if she was sole at her will & pleasure according to the
agreement & trust aforesaid make any disposal & appointment of the
estate aforesaid whether real or personal as is herein before particularly
recited & that the said Jesse Jones his heirs & assigns shall & may execute
& perform the trust herein given him without the suit trouble or
interruption of him the said Thomas Lane his heirs executors & assigns
that the said Jesse Jones his heirs or assigns shall be only & to be
wise & accountable for such estates as shall actually come to his possession
by virtue of the trusts aforesaid & that the said Jesse Jones shall be
saved harmless & kept indemnified of & from all cost charges & damages
as he shall sustain or expend for or by reason of the trusts aforesaid & that
the said Thomas Lane his heirs shall & will from time to time
upon the request & at the cost of the said Lucy Jones & Jesse Jones
make do & execute all & every act or acts as aforesaid for the
