 Executor W. of Miles Cary Decd of the county of Southampton of the one part
 and Richard Blow of the parish of St Luke and county afores^d of the other part
 Witnesseth that the s^d Henry Taylor for and in consideration of the sum of
 £200 pounds to him hand paid by the s^d Richard Blow at or before the seal-
 ing and delivery of these presents the Receipt whereof the s^d Henry Taylor
 doth hereby acknowledge and thereof acquit and discharge the s^d Rich^d
 Blow his heirs Executors forever by these presents he the s^d Henry Taylor
 hath granted bargained sold released and confirmed and by these
 presents doth grant bargain sell release and confirm unto the s^d Rich^d Blow
^{separate piece and lying on the South side of Millway near or Blackhorn road the same being}
 his heirs and assigns forever one plantation tract or certain parcel of land formerly
 the s^d Miles Cary decd of the Holloway Indians & devised by the s^d Miles Cary decd
 will to be sold reference thereunto may more fully appear the s^d plantation tract or
 parcel of land containing 529 acres more or less now in the tenure & occupation
 of the s^d Rich^d Blow together with all houses out houses & diverse buildings woods & water

 and profits thereof and all the Estate right title Interest Trust possession Property
