This Indenture made this 11 day of November in the year of our Lord 1683
Between Jesse Vaper of the county of Southampton of the one part
Pope of the county of aforesaid of the other part Witnesseth that the said
Pope for an in consideration of the sum of eleven hundred pounds
lawfully by the said Jonathan Pope the receipt whereof the said Jesse
Vaper doth hereby acknowledge himself fully contented satisfied
and paid hath bargained sold aliened, released, and conveyed
and by these presents doth grant bargain sell alien conveyed
confirm unto the said Jonathan Pope his heirs and assigns forever
one certain tract or parcel of land Situate lying adjacent to
county of Southampton on the south side of the highway which
One hundred acres more or less the said piece of land being part
of a patent granted to William Savineth bearing date the 13 day of
July 17th and bounded as followeth to wit beginning at a red oak
tree of Robert Newsons land thence by a curved line North 35
degrees East 59 poles to three trees & thence North 35 degrees
East 100 pole to a black oak and East North East 12 1/2 poles to a
then south 50 degrees East 20 pole to a red oak a corner tree of
land thence by a line south 10 degrees west 61 pole to a corner
of Robert Vicks land then by Robert Vicks line west 66 pole to a
then South 20 degrees West Sixty pole to a pine then by a line of
trees crossing the survey to the beginning with all & singular the
outhouses gardens yards orchards waters water courses and all the
Right common profits privileges and appurtenances thereto belonging
over anywise appertaining to have to hold the said granted
bargained land and premises appurtenances unto the said Jonathan
Pope his heirs and assigns forever in a sure possession & estate of
inheritance in fee simple and the said Jesse Vaper for himself
and his heirs the said plantation and premises and every part
thereof against him and his heirs and against all and every other
person or persons whatsoever unto the said Jonathan Pope his
heirs and assigns shall and will warrant and forever defend
