

This Indenture made this 29 day of August and in the year
of our Lord Christ 1771 Between Simon Harris & Rebekah his wife of the
parish of Wottonway and Shadrach Johnson & Ann his wife of the
parish of Wottonway & County of Isle of Wight of the one part & John Johnson Junr
of the parish of Wottonway & County of Southampton of the other part
Witnesseth that the said Simon Harris and Rebekah his wife & Shadrach
Johnson for the Receipt whereof the said Simon and Rebekah
Harris and Shadrach and Ann Johnson doth hereby acknowledge
lawfull money of Virginia to them in hand paid by the said John
Johnson Junr the said Simon Harris and Rebekah his wife & Shadrach
Johnson doth acquit and discharge the said John Johnson Junr
his heirs executors and assigns by these presents hath bargained
granted sold aliened enfeoffed & confirmed and by these presents
do bargain grant sell alien enfeoff & confirm unto the said John
Johnson Junr & to his heirs and assigns forever all that tract or
parcel of land lying & being in the aforesaid parish of Wottonway
and County of Southampton containing by estimation 100 acres
or thereabouts more or less & bounded as followeth (to wit) Beginning
at Black Creek run at the mouth of the hogpen branch then running
up the said branch by Samuel Johnson's plantation to a line of marked
trees making out of said hogpen branch which is John Popes
line son of Joseph Popes Decd. the said line of marked trees mak-
ing to the head of a small branch then down the said branch
to black creek run from thence down the said Run to the Beginning
together with all houses out houses edifices buildings yards garden
orchards trees ways waters watercourses profits commodities heredita-
ments and appurtenances to the said plantation tract or parcel of
land belonging or in any ways appertaining and the Reversion and
and reversions remainders & remainders with Issues & profits thereof
and every part and parcel thereof and all the estate right title &
possession claim & demand whatsoever of them the said Simon and
Rebekah Harris and Shadrach and Ann Johnson of or to
the same or any part or parcel thereof and all the deeds evidences and
writings touching or in any ways concerning the same To have & to hold
the said plantation tract or parcel of land & premises with the appurten-
ances unto the said John Johnson Junr his heirs and assigns to the only
use and behoof of him the said John Johnson Junr his heirs & assigns
forever and the said Simon and Rebekah Harris & Shadrach
and Ann Johnson for themselves their heirs executors & assigns
doth given and promise & grant to and with the said John Johnson
Junr his heirs & assigns by these presents that the said Simon and
Rebekah Harris & Shadrach & Ann Johnson & their heirs & assigns
aforesaid the premises with the appurtenances unto the said John
Johnson Junr his heirs and assigns against all and every person &
persons whatsoever lawfully claiming or to claim the same by from under
him them or any of them or any other person or persons whatsoever
shall and will warrant & forever defend by these presents In Wit-
ness whereof the said Simon & Rebekah Harris & Shadrach & Ann
Johnson hath hereunto set our hands & affixed our seals the day & year
first above written
