This Indenture made this 13 day of Decr in the year of our Lord 1771
Between John Duffin of the parish of Holloway and County of South
of the one part & William Machey of the same parish & County of the other
part Witnesseth that the said John Duffin as well for his consideration
of the natural love & Affection which he beareth unto William Machey his son
in Law as also for Consideration of the sum of £1000 in hand paid by the
said Machey therewith whereof he doth hereby acknowledge hath given
granted bargain'd sold alien'd releas'd & confirmed by their presents Deth
give grant bargain sell alien release and confirm unto William Machey & to
his heirs and assigns all that plantation tract or parcel of land & premises
with the appurtenances now or then to be or Occupied by the said William
Machey & who is now situate lying being in the parish
of Holloway & County of Southampton containing by estimation 150
acres be the same more or less and bounded as followeth Beginning at the mouth
of the gum Branch at black creek along the run of the said Branch to a pine
tree and from a line marked trees to Jonathan Bowens line by the said
Bowens line to black creek & along the run of black creek to the first station with
all houses out houses evidences buildings yards gardens orchards & whatsoever
water courses profits commodities hereditaments & appurtenances to the said
tract or parcel of land belonging or in anywise appertaining & the reversion
and Reversion remainders & remainders thereto & Issues & profits thereof &
all the estate right title interest use trust possession property claim & demand
whatsoever of them the said John Duffin of or to the same & every part thereof
