This Indenture made the tenth day of August in the year of our Lord God 1772
 Between Cornelius Mabry & Hannah his wife of the County of Southampton in the
 part of Owen Myrick of the aforesaid of the other part witnesseth that the said
 Cornelius Mabry & Hannah his wife for and in consideration of the sum of Twenty
 pounds to them in hand paid by the said Owen Myrick before the sealing &
 delivery hereof the receipt whereof the said Cornelius Mabry & Hannah his wife
 doth hereby acknowledge hath granted bargained & sold & doth by these presents
 grant bargain & sell unto the said Owen Myrick his heirs and assigns forever
 a certain tract or parcel of Land lying & being on the South Side of Cottaway
 River in the county of Alford & bounded as follows to wit Beginning at a sweet Gum
 on the south side of the hornet swamp thence south 7 degrees West 102 poles to a White Oak
 then south 37 degrees West 116 poles a pine then North 28 degrees West 63 poles to a
 Black then North 87 Degrees West 170 poles a red Oak then North 27 Degrees West
 30 poles a pine by the side of the Hornet swamp aforesaid & down the various courses of the
 Run of the said swamp to the beginning of all an singular the houses buildings
 buildings Barns stable Gardens orchards wood underwood waters watercours & garments
 & fit Commodities hereditaments Appurtenances whatsoever to the said Measuring
 Tercement Land & premises above mentioned or any part thereof & the reversion and
 Reversionary remainder and remainders rents & services of all & singular the
 Premises & also all the estate right title interest property claims & demands
 whatsoever of them the said Cornelius Mabry & Hannah his wife give to the
 with their & every of their affairs to hold the same manor & tenement & lands
 with their Measur'd lands and premises freely granted & Conveyed with their
 aforesaid Appurtenances unto into the said Owen Myrick his heirs & assigns to the only proper
 Witnes of him the said Owen Myrick his heirs and assigns forever & the said bonding

 doth covenant promise & grant to and with the said Owen Myrick his heirs and

 & lawfully may from time forth forever & thereafter peaceably quietly have
 hold use occupy possess & enjoy the said Measuring Tercement Land & premises
 above mentioned and sufficiently saved & kept harmless of and from all titles &
 troubles charges and incumbrances whatsoever by them the said Cornelius Mabry
 & Hannah his wife their heirs executors or adm'rs or any other person or persons
 lawfully claiming or to claim by power under him them or any either of
 them in witness whereof we have hereunto set our hands and
