 Witnesseth that the said Thomas Wills for and in consideration of  
 the sum of Forty five pounds eighteen Shillings & Six pence  
 to him in hand by the said Jos. Wm. Scott or before the sealing &  
 delivery of these presents the Receipt whereof he doth hereby  
 Acknowledge & thereof Acquit and discharge the said Jos. & Wm. Scott  
 his heirs & Adms. by these presents hath Granted bargained sold  
 alien released & confirmed & by these presents doth Grant bargain  
 sell alien release & confirm unto the said Jos. & Wm. Scott & their  
 Heirs & assigns forever all that plantation Tract or parcel of  
 land whereon the said Thomas Wills now lives containing by  
 estimation seven Hundred & Fifty Acres more or less together  
 with all Houses Outhouses Edifices buildings Woods Ways Waters Water  
 Courses profits Commodities Hereditaments & Appurtenances whatsoever  
 to said plantation Tract or parcel of land belonging or in any wayes Apper  
 taining And the reversion & reversions remainder & remainders rents  
 issues & profits thereof & interest of him the said Thomas Wills of & to  
 the same any & every part thereof To have & to hold the said  
 plantation Tract or parcel of land & premises with the Appurtenances  
 unto the said Jos. & Wm. Scott their Heirs & assigns forever To them &  
 their Only proper use & behoof forever provided always & upon this  
 Condition that if the said Thomas Wills his heirs Executors or Adms  
 or some or one of them do well & truly pay or cause to be paid unto  
 the said Jos. & Wm. Scott their Heirs Executors or before the Twelfth  
 day of July next ensuing the date hereof the said sum of Forty
