 Pounds Lawfull Money of Virginia to him in hand paid by the said John Johnson the Receipt
 whereof the said David Chalmer doth hereby Acknowledge & thereof Acquits & Discharge the
 said John Johnson his Heirs Executors Administrators by these presents with Bargain
 Granted Sold Alienor & confirmed by these presents doth Bargain Grant sell Alien
 in full & confirm unto the said John Johnson & his Heirs & Assigns forever All that
 Tract or parcel of Land lying & being in the aforesaid County of Southampton Containi
 ng by Estimation one hundred Acres to the same more or less & bounded as followeth
 to wit Beginning at the Mouth of Messers Branch & along the said Branch
 to a Poplar a line Tree of John Turners from thence along a line of marked Trees of said
