 and seventy three Between Shadrach Lewis of the County of Southampton Parish of
 St. Michael the One part & John Branch of the Same Parish & County of the Other part Witnesses
 at the said Shadrach Lewis for in Consideration of the Sum of Thirteen Pounds Current
 Money of Virginia to him in hand paid Compt by the said John Branch the receipt of the said
 Shadrach Lewis do hereby Acknowledge himself of the said fully & Intirely satisfied
 Contented & paid have Granted Bargained & sold by these presents to Grant Assigns & Sell
 Alien en Joy & Confirm to Love & deliver unto the said John Branch his Heirs & Assigns
 forever one Certain Tract or parcel of land situate lying & being in the County aforesaid
 of Parish of Millonway on the North side of Millonway River containing by Estimation
 Seventy Acres be the same more or less & Bounded as followeth to wit Beginning at a
 pine sapling in Charles Calthorpes line thence the said Lone Oak a corner tree of the said
 Calthorpes line thence to pine corner of the said Calthorpes & Arthur Joiners line thence
 the said Joiners line to a red oak corner tree of the said Arthur Joiners & Nicholas
 Williams lines thence a line of Marked trees to the Beginning the said land
 being part of a tract Granted to Lewis Joiner by Patent bearing Date the
 Twelfth Day of February One Thousand seven hundred & Sixty one & by the
 Lewis Joiner Conveyed to the said Joshua Goss by deed of Bargain & Sale & Record
 ed in the Court of Southampton County the Eleventh Day of March One thousand
 seven hundred & Sixty two then Conveyed to the said Shadrach Lewis by Virtue
 of Deed bearing Date the tenth Day of November One thousand seven hundred
 & Seventy And Recorded in the Court of Southampton County the tenth Day of Jan^y
 One thousand seven hundred & Seventy one To have & to hold the said plantation
 tract or parcel of land with the Appurtenances Now Mentioned every part &
 parcel thereof to the only use & behoof of the said John Branch to his Heirs & Assigns
 forever & the said Shadrach Lewis for himself his Heirs & Assigns Admors & Assigns
 the said plantation tract or parcel of land & Appurtenances with every part & parcel
 thereof Against himself his Heirs & Assigns Admors Against all & every other person or
 persons whatsoever Claiming or Demanding the same or any part thereof shall
 Warrant & never Defend by these presents In Witness whereof the said Shadrach
 Lewis has hereunto set his hand & Affixed his seal this Day & year first above
