This Indenture made this 10 day of March 1769 Between Day Ridley  
of the County of Hertford and Province of North Carolina of the one part & Bery Jarnell  
of the Parish of St Luke & County of Southampton of the other Part Witnesseth that  
the said Day Ridley for and in consideration of the sum of Fifty Pounds to him  
in hand paid by the said Bery Jarnell at or before the sealing and  
delivery of these Presents the receipt whereof the said Day Ridley doth hereby  
acknowledge and of thereof acquit and discharge the said Bery Jarnell his  
heirs Executors Administrators by these presents He the said Day Ridley hath Granted  
bargained sold Menue Released and Confirmed and by these presents hath Granted  
Bargained sold Alien Released & Confirmed unto the said Bery Jarnell his heirs  
and assigns forever one certain Tract or Parcel of Land situate lying & being  
in the Parish & County aforesaid and bounded as followeth to wit Beginning  
at two Pines & a small Post oak & thence Inwards in Henry Taylors line thence  
of Mark trees made for that Purpose to a small white oak standing in the  
Head of a branch thence down the said Branch to a Green  
standing in said Bery Jarnell line thence along said Jarnell line to  
Bery Barkams Corner thence along the said Bery Barkams line  
to Henry Taylors Corner thence along said Taylors line to the beginning containing  
Fifty Acres be the same more or less Together with all Houses Outhouses  
Cellars Buildings Woods Mairs water Courses Waters Sods Grounds Profits  
Commodities Hereditaments & Appurtenances whatsoever & the Reversion  
and Reversion Remainder & Remains & Rents Issues & Profits thereof  
And all the Estate Right Title Interest Use Trust Possession Property  
Benefit Claim and Demand of him the said Day Ridley of and to the same any  
and every part thereof And All Deeds Evidences & Writings touching or concerning  
The premises to have and to hold the said Plantation Tract or parcel  
of Land & premises herein before Mentioned with the Appurtenances unto the said Bery Jarnell  
and his heirs and assigns to the only proper use & behoof of him the said Bery Jarnell  
and his heirs & assigns forever And the said Day Ridley & his heirs the Plantation  
Tract or parcel of Land and premises hereby Bargained & sold unto the said Bery Jarnell  
and his heirs and assigns and every and all of them against him the said Day Ridley  
and his heirs and against All and every other Persons and Persons whatsoever shall & will  
Warrant and forever defend by these presents In Witness whereof the said Day Ridley hath  
to these presents set his hand and Seal this Day & Year above written
