This Indenture made this Fourth day of October on Thousand seven hundred
 & Seventy Three between Nathaniel Howell and Ann his wife of the Province of South
 Carolina of the one part and Hartwell Howell of the County of Brunswick in
 the Colony of Virginia of the other part Witnesseth that the said Nathaniel Howell and
 Ann his wife for and in Consideration of the sum of Fifty Pounds Currant money
 of Virg^a to them in hand paid by the said Hartwell Howell at or before the
 Sealing and Delivery of these presents the Receipt whereof the said Nathaniel Howell
 & Ann his wife doth hereby Acknowledge they acquit & discharge the said
 Hartwell Howell his heirs & assigns forever by these presents they the said
 Howell & Ann his wife hath granted Bargained Sold Alien Released &
 Confirmed & by these Presents Doth Grant Bargain Sell Alien Released &
 Confirm unto the said Hartwell Howell his heirs & assigns forever All that
 the said Nathaniel Howell his Plantation Tract or Parcel of Land Situated lying
 and being on the South Side of Three Creeks in the Colony afores^d in the parish
 of Sussex and County of Southampton containing 175 acres & the same more or less
 being the Land conveyed by Deed duly Proved & Recorded in the County Court of
 afores^d from Benwell Alkingson & Olive his wife unto the said Nathaniel Howell in
 the said being Had may now fully and at Large appear Together with all House
 Outhouses Cottages Building, Woods Waifs Watercourses Waters Low Grounds Rights
 Commodities Hereditaments & appurtenances over and the Reversion & Remainders
 Remainder & Remainders Rents Issues & Profits thereof and all the Estate Right
 Title Int^r Use Trust Possession Property Benefit Claim & Demand of them the
 said Nathaniel Howell & Ann his wife of in & to the same any & every Part thereof and all Deeds
 Evidences & Writings touching or concerning the Premises (to have & hold the said Plantation
 Tract or Parcel of Land and premises herein before mentioned) with the Appurtenances to the said Hartwell
 Howell and his heirs & assigns To the only proper use & behoof of him the said Hartwell & his heirs &
 assigns forever And the said Nathaniel Howell and Ann his wife & their heirs the said
 Plantation tract or Parcel of Land & Premises hereby bargained & sold unto the said
 Hartwell Howell and his heirs & assigns every and all of them against them the said Nathaniel
 Howell & Ann his wife & their heirs and against all and every other Person & Persons whatsoever
 Shall and will warrant & defend by these Presents In Witness whereof the said
 Nathaniel Howell and Ann his wife hath to these Presents set their hands & seals
