To all to whom these presents shall come Greeting, Know ye that Benjamin Bailey of the County of Surrey Merchant for and in Consideration of the sum of Eighty five pounds Good money of Virginia to me in hand paid by Isaac Williams of the County of Southampton planter Have and by these presents do grant bargain sell & deliver unto the said Isaac Williams one negro man slave named Andrew To have and to hold the said slave Andrew unto the said Isaac Williams his heirs and assigns to the only proper use & behoof of the said Isaac Williams his heirs & assigns forever which said slave Andrew is now lawfully sold & conveyed to the said Isaac Williams by Virtue & in pursuance of a certain indentured deed of purchase from one Thomas Milt to the said Benjamin Bailey bearing date the 11 day of June 1772 duly proved & recorded in the County Court of Southampton citation being thereto had more fully and at large may appear And the said Benjamin Bailey do hereby for myself my heirs Ex^{or} & adm^r covenant grant & agree with the said Isaac Williams his heirs & assigns forever by these presents to warrant and defend the title of the said slave Andrew to the said Isaac Williams his heirs & assigns against the title claim or demand of any person or persons whatsoever In Witness whereof I have hereto put my hand & affixed my seal this Tenth day of June in the year of our Lord Christ 1773

This Indenture made this 9th day of Dec^r in the year of our Lord Christ one thousand seven hundred & seventy three between Jordan Denson of the parish of Cottoway & County of Southampton of the one part & Isaac Williams of the parish of Cottoway & County of Southampton of the other part Witnesseth that the said Jordan Denson for and in consideration of the sum of £5. 0. 6. current money of Eng^l by the said Isaac Williams to him in hand paid at or before the sealing & delivery of these presents the receipt whereof the said Jordan Denson doth hereby acknowledge & thereof acquit discharge the said Isaac Williams his heirs Ex^{or} & adm^r & assigns forever and himself therewith fully & entirely satisfied Contented & paid by these presents the said Jordan Denson hath Granted bargain'd sold alien'd enfeoff'd & confirmed And by these presents doth grant bargain sell alien enfeoff & confirm unto
