This Indenture made this 28 day of Jan^y 1774 Between Jesse Bull & Lydia his wife
in the county of Southampton and Parish of Mottoway of the one part & Pasco Turner
of the other part County and Parish of the other part Witnesseth that the s^d Jesse Bull & Lydia Bull
for in consideration of the sum of fifteen Pounds lawful money of Virginia to them in
hand paid by the s^d Pasco Turner the receipt whereof the s^d Jesse Bull & Lydia Bull
Bull doth hereby acknowledge and thereof acquit & discharge the s^d Pasco Turner
his heirs Executors & administrators by these Presents hath bargained granted sold
aliened enfeoffed & confirmed by these presents doth bargain grant sell alien
enfeoff & confirm unto the s^d Pasco Turner his heirs & assigns forever all that
plantation tract or parcel of Land lying & being in the s^d County of Southampton
& Parish of Mottoway containing by Estimation fifty acres be the same more or
less and bounded as followeth to wit Beginning at a red Oak a Corner tree
of Hardy Laurence's line from thence a long line of marked trees of Laurence
to a pine a corner tree of Jesse Bull's line from thence along a line of marked trees
of Bull's to a light wood stump between s^d Bull's John Luke & Simon & Mary from
thence along a line of marked trees of s^d Luke's line to a pine a corner tree from thence
down now head swamp to the Beginning together with all houses out houses
edificies buildings yards gardens orchards trees ways waters Water courses
Profits commodities hereditaments & appurtenances to the s^d Plantation tract or
parcel of land belonging or in anywise appertaining & the reversion and
reversions remainders & remainders parts of parts & Profits thereof of every part
and Parcel thereof & all the Estate right title Interest Property possession claims
& demand whatsoever of them the s^d Jesse & Lydia Bull's of in or to the same or
any part or parcel thereof & all deeds evidences & writings touching or in any
way concerning the same To have and to hold the s^d plantation tract or
parcel of land & premises with the appurtenances unto the s^d Pasco Turner his heirs &
assigns to the only use & behoof of him the s^d Pasco Turner his heirs & assigns forever
and the s^d Jesse & Lydia Bull's for themselves their heirs & assigns doth
covenant promise & grant to and with the s^d Pasco Turner his heirs & assigns by
these presents that the s^d Lydia & Jesse Bull's their heirs & assigns of the s^d
premises with the appurtenances unto the s^d Pasco Turner his heirs & assigns against all
persons & persons whatsoever lawfully claiming or to claim the same by force or
wrong or in or to them or any of them or any other person or persons whatsoever
shall and will warrant and forever defend by these presents In Witness
whereof The s^d Jesse & Lydia Bull's hath hereunto set our hands &
