 William Andrews of Southampton County of the one part & Moses Harris of the s^d
 County of the other part Witnesseth that the s^d William Andrews for and
 in consideration of the sum of twenty pounds full money of Virginia to him in hand
 paid by the s^d Moses Harris the receipt of the said William Andrews doth hereby
 acknowledge have granted bargained sold alien & confirmed & by their
 presents do grant bargain sell alien & confirm unto the s^d Moses Harris his
 heirs & assigns forever one certain tract or parcel of land containing by
 sixteen acres betwixt the same now or less lying & being in the county afores^d the
 North side of the Three Creeks on both side of the Main road that the said
 William Andrews purchased of Charles Baps & bounded as followeth
 Beginning at Moses Shoopes line on the south side of the road thence
 East along a line of market trees two hundred & eighty yards a corner tree
 thence North along a line of market trees two hundred & eighty yards to a
 corner tree thence West along a line of market trees two hundred & eighty
 yards to Moses Shoopes line thence South along the s^d Shoopes line to
