This Indenture made the 18 day of November in the year of
our Lord one thousand seven hundred and seventy six Between Jesse
Jones and Francis his wife of the county of Southampton of the one part and
Nathaniel Felts of Sussex County of the other part Witnesseth that
the said Jesse Jones and Francis his wife for and in consideration of the
sum of Eighty ^{nine} pounds two shillings current money of Virginia to him
in hand paid by the said Nathaniel Felts before the sealing and
delivery hereof the receipt whereof the said Jesse Jones and Francis
his wife doth hereby acknowledge hath granted bargained and
sold and doth hereby these presents grant bargain and sell unto
the said Nathaniel Felts his heirs and assigns a certain tract
or parcel of land lying and being in the county of Southampton
aforesaid and on the south side of round hill swamp containing
Two hundred and ninety seven acres part of a patent granted
to the said Jesse Jones bearing date the 12 day of May 1759 and
bounded as followeth Beginning at the mouth of Susquahanna
and up the said branch of the mouth of the old field branch thence
up the said branch to a willow oak thence along a line of marked
trees to the run of the said branch thence up the said branch to
Richard Ponds line thence along a line a line marked trees to Henry
Browns line thence along the said Browns line to the run of round
hill swamp thence down the said swamp to the beginning and the
Reversion and Reversions remainder and remainders rents issues &
profits thereof and the estate right title interest claim and demand
whatsoever of them the said Jesse Jones and Francis his wife and
their heirs or to the same or any part thereof To have and to
hold the said and premises with the appurtenances unto the said
Nathaniel Felts his heirs and assigns for ever and the said Jesse
Jones and Francis his wife and their heirs the said land and
