This Indenture made the 29th day of October in the year of our Lord and Saviour Jesus Christ one thousand seven hundred and seventy seven Between Jonathan Pope and his wife Amy of the County of Southampton and State of Virginia of the one part and George Gurley of the County and State aforesaid of the other part Witnesseth that the said Jonathan Pope for and in Consideration of the sum of Thirty two pounds of good and lawfull money of Virginia to him in hand paid by the said George Gurley before the sealing and delivery of these presents the receipt whereof he doth hereby acknowledge and own himself fully satisfied herewith and thereof doth acquit the said George Gurley ~~and having done grant bargain sell alien~~ ~~confirms~~ and by these presents have given granted bargained sold aliened enfeoffed and confirmed unto George Gurley his heirs and assigns for ever a certain tract or parcel of land lying and being in the County of Southampton aforesaid containing one hundred acres more or less the said land being part of a patent granted to William Faircloth bearing date the thirtieth day of August one thousand seven hundred and forty three and bounded as followeth to wit Beginning at a Red oak a corner of Robert Newsoms lane & North thirty five degrees East fifty nine pole to three trees chopped inward Then South thirty five degrees East one hundred pole to a Black oak then East North East one hundred and twenty four pole to a hickory Then South fifteen degrees East twenty pole to a Red oak a corner of John Vicks land then by John Vicks lines South ten degrees West sixty one pole to a pine a corner of Robert Vicks land then by Robert Vicks lines West sixty five pole to a pine Then South twenty degrees West sixty pole to a pine Then by a line of Marked trees crossing the Survey to the Beginning with all trees woods underwoods common commons of Pastures Profits Commodities And advantages Emoluments and Hereditaments whatsoever to the plantation or tract of land belonging or in any wise appertaining or upon the same growing happening or arising and also the Reversion and Reversions Remainder and Remainders ^{Value over the whole right title interest claim & demand whatsoever of him the said Jonathan Pope or of his heirs} thereof To Rents and services of the premises and every part thereof To have and to hold all and singular the said premises above mentioned and every part and parcel thereof with the appurtenances unto the said George Gurley his heirs or assigns for ever & the said Jonathan Pope for himself and his heirs the said Plantation and premises and every part thereof against him and his heirs and against all and every other person or persons whatsoever unto the said George Gurley his heirs and assigns shall and will warrant and for ever defend by these presents In Witness whereof the said Jonathan Pope and his wife Amy have here unto set their hands and affixed their seals this day and year above written
