pounds good and lawfull money of the colony of Virginia to him in
hand paid at and before the enscadining and delivery of these presents
by the said Matthew Vick the Receipt whereof he doth himself hereof
acknowledge to be fully Satisfied Contented and paid hath bargained
enfeoffed and confirmed and by these presents doth bargain sell alien
convey and forever Confirm unto the said his Heirs Vick his Heirs and
assigns a certain Tract or parcel of land lying and on the North
side of Nottoway River in the County of ~~Southampton~~ which said tract
or parcel of land Richard Vick Senior purchased of one John Gent
of Edgecomb County north Carolina as by deed Recorded in the County
Court of Isleworth will more fully and all largely appear and by the
said Richard Vick devised in his last will and Testament in full
unto his son Josiah Vick now freely to these presents which said bears
date Twenty third day of July one thousand seven hundred and fifty
seven proved and received in the County Court of Southampton and
by the presents act of assembly of this State made and provided for making
the intails of Lands &c has become unto the said Josiah Vick and an Estate
in fee simple which said Tract or parcel of Land containing by estimation
Three hundred acres to the same more or less according to the bounds thereof
Viz] Beginning at a red oak standing upon Nottoway River bank a corner
tree then running along a line of marked trees and a East Course to a sweet
gum standing in a branch a line Tree of the patent then up the said line
to a marked hickory a corner Tree and then along a line of marked trees
a west Course to a holly standing upon the bank of the river aforesaid a
corner Tree then down the said River to the first Station the said plantat
ion Tract or parcel of Land with All woods under woods gardens water
ways mines minerals with all other profits Commodities advantages
Emoluments and hereditaments whatsoever thereunto belonging or in any
wise appertaining or upon the same growing hoping and arising with the reversions
and reversion Remainder and remainders Rents Services and profits thereof
