 of the County of Southampton by his certain indenture of mortgage bearing
 date the first day of November 1777 did sell and convey unto James
 Moore and to his heirs and assigns one certain tract or parcel of land
 wherein the said Arthur Joyner then dwelt lying in the County aforesaid
 containing one hundred and six acres for the consideration and
 securing the payment of fifty six pounds four shillings with interest
 then justly due to the said James Moore his heirs executors administrators
 or assigns and whereas since the death of the said James Moore
 the aforesaid Arthur Joyner hath paid and satisfied unto Jesse Williams
 and to Isaac Williams the lawful administrators of the said James
 Moore the aforesaid sum of fifty six pounds four shillings and the interest
 arising thereon to the date hereof Now know ye that we the said Jesse
 Williams and Isaac Williams administrators of the above said James
 Moore for the consideration aforesaid have and by these presents do unite
 release and forever quit claim unto the aforesaid Arthur Joyner
 and to his heirs and assigns all all the right title interest claim or
 demand of them the aforesaid Jesse Williams and Isaac Williams of the
 aforesaid James Moore otherwise of in or to the aforesaid tract or parcel
 of Land mentioned to be conveyed in and by the aforesaid indenture
 of mortgage herein before mentioned and we do hereby acquit and
 discharge the aforesaid Arthur Joyner his executors administrators
 and assigns from the said debt and demand witness our hands and
