This Indenture made this Fifth day of February in the year of our
 Lord Christ one thousand Seven hundred and seventy nine between
 John Drake of the County of Southampton of the one part and Elijah
 Pope of the other part witnesseth that for and in consideration of the sum
 of two hundred and fifty pounds current money of Virginia to the said
 John Drake in hand paid by the said Elijah Pope the receipt whereof
 the said John Drake doth acknowledge and thereof acquit the said Eli-
 jah Pope his heirs Executors and administrators by these presents hath given
 granted alien and confirmed and by these presents doth give grant alien
 and confirm unto the said Elijah Pope his heirs and assigns part of two
 several tracts or parcels of land containing in all by estimation One hundred
 and Seventy eight Acres be the same more or less situate and being in the
 aforesaid County of Southampton beginning at a hickory on the west corner
 Swamp thence along John Wilkinsons line to a pine a corner thence along
 a line marked trees to a white oak on Paxells Branch thence down the
 said branch to trout house Swamp thence down said swamp to the
 beginning being part of a patent granted to Nathaniel Powell Seventy eight
 acres the residue and Remainder thereof granted to Arthur Taylor by
 patent bearing date the fifth day August Anno Domini one thousand Seven
 hundred and fifty one and by conveyance since became vested in the said
 John Drake partly to these presents and Bounded as followeth viz. beginning
 at a Turkey oak in James Edmunds line thence to a pine a corner thence
 along his line a red oak a corner thence his line to a Red oak a corner
 thence his line to a pine a corner thence along a line of marked trees to
 the mill Branch thence up said Branch to a maple Jonas Bryant
