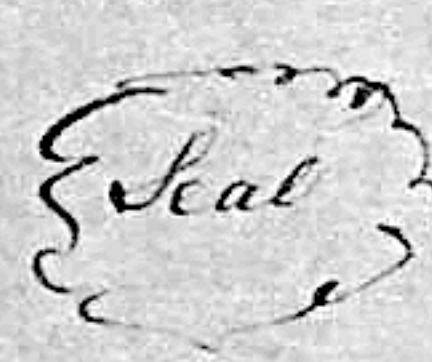


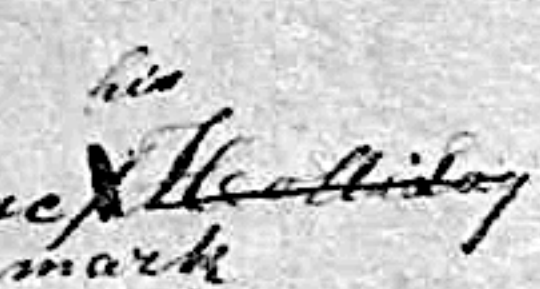

This Indenture made this twenty ninth day of May in the year of our Lord one thousand Seven hundred and and Seventy nine between Josiah Vick of the parish of Nottoway and County of Southampton of the one part and Robert Speed of the same County of the other part witnesseth that the said Josiah Vick for and in consideration of the sum of ninety five pounds Current money of Virginia the receipt whereof he doth hereby acknowledge and thereof acquit and forever discharge the said Robert Speed his heirs executors administrators and assigns hath granted bargained sold aliened released enfeoffed and confirmed and by these presents doth grant bargain sell alien released enfeoff and confirm unto the said Robert Speed and his heirs forever a certain tract or parcel of Land Situate lying and being in the parish of Nottoway County aforesaid containing by estimation ninety four Acres more or less and bounded as followeth to wit: Beginning at a Gum standing in Nottoway swamp
