State of Virginia of the other part witnesseth that the said Nathan
Byrd and Martha his wife for and in consideration of the Sum

paid by the said Elijah Crocker at or before the enrolling and Delivery
of these presents the Receipt whereof the said Nathan Byrd and Mar-
tha his wife doth hereby acknowledge hath granted bargain sold
Alien and confirmed by these presents doth grant bargain sell alien
and confirm unto the said Elijah Crocker and to his heirs and assigns
forever one certain tract parcel or dividend of Land containing
By estimation one hundred and fifty Acres if being part of a Survey
of Thomas Williams's lying and being on the North side of Mchering
River in Southampton County beginning as bounds at a Cypress tree
in John Williams's line then along a line of marked trees to a corner
Oak in Cordall's Norfluke's line thence along his line to a gum in
Moses Johnson's line then along his line to the road then along
the road to Buckhorn then down the said Buckhorn ~~the~~ beginning
and all houses out houses buildings yards Orchards wood ways water
water Cows profits Commodities hereditaments and appurtenances to the
tract or parcel of land and premises with the Appurtenances there
belonging or in any wise hereunto appertaining the reversions
