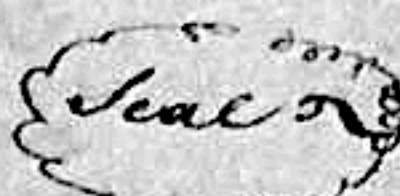

To all to whom these presents shall come I Peter Butts do send greeting.
Know ye that I the said Peter of the Parish of Vottoway in the county
of Southampton for and in consideration of the love and affection which I
have and do bear towards my son James Butts of the parish and county aforesaid
saia have given and granted and by these presents do freely clearly and
absolutely give and grant unto the said James Butts his heirs Executors
or administrators one certain tract or parcel of Land containing four
hundred and fifty Acres it being the land he now lives on lying & being in the aforesaid
County and parish together with the slaves following to wit Bob Tempery
Charles and Abolam To have and to hold all the aforesaid land and
slaves to him the said James Butts and his heirs or assigns forever
from hence forth as his or their Absolute property without any manner
of condition in witness whereof I have hereunto set my hand and seal
this sixth day of September in the 4th year of this Common wealth by the Grace
of God in the year of our Lord God 1779

This Indenture made this fourteenth day of October in the year of our Lord
Christone the thousand seven hundred and Seventy nine and in the fourth
year of the common wealth of Virginia Between Micajah Atkinson and
Martha Cooper Atkinson his wife of the parish of Vottoway and county
of Southampton of the one part and Solomon Holmes of the parish of Vottoway
& county of Isle of Wight of the other part witnesseth that for and in considera-
tion of two Negroes namely Rose & Joe by the said Solomon Holmes
to the said Micajah Atkinson in hand delivered at or before the sealing
and delivery thereof the receipt whereof the said Micajah Atkinson doth
hereby acknowledge they the said Michael Atkinson and Martha Cooper
Atkinson his wife have granted bargain sold alien Enfeoffed & confirm
by these presents do grant bargain sold alien release & confirm
unto the said Solomon Holmes his heirs and assigns forever all that
plantation tract or parcel of Land and premises situate lying and being
in the county aforesaid containing by estimation two
