This Indenture made the Thirtieth day of October in the year of our Lord one thousand Seven hundred and Seventy Nine between Nathaniel Tatum of Southampton County of the one part & Thomas Milliner of the other Part witnesses that the said Nathaniel Tatum & John Fort doth hereby have granted bargain & sold aliened & confirm and by these presents doth grant bargain sell aliened & confirm unto the said Thomas Milliner his heirs and assigns forever one certain tract of land containing two hundred and Twenty five Acres more or Less lying & being in Southampton County and beginning as followeth at a black gum on the east side of the North prong of the hornet Swamp at a corner of John Forts Land thence North east one hundred and eighty poles to a white oak a corner of the said Forts thence the same course Sixty poles to a Red oak thence by a new line to a pine in a branch thence down the said branch to Henry Manwias a pine thence along the said line to the County Line Joining John Knights thence by the said line to a black oak a corner Tree of Thomas Newsoms thence down the said Newsoms line to the North prong of the hornet Swamp thence down the said swamp to the beginning To have and to hold the said tract or parcel of Land with the Appurtenances unto the said Thomas Milliner his heirs and assigns together with all profits commodities advantages hereditaments whatsoever also the reversions & Reversions remainder & remainders Rents & Services of the said Land and premises & of every part thereof and also all the estate Right Title Interest Claim and Demand whatsoever of the said Nathaniel Tatum & John Fort their heirs & assigns forever of into the said Land & premises above mentioned and every part thereof with the appurtenances unto the said Thomas Milliner his heirs & assigns to the only proper use and behoof of the said Thomas Milliner his heirs & assigns forever & the said Nathaniel Tatum & John Fort for themselves their heirs or assigns the said Land & premises and every part and parcel thereof against me my heirs or assigns all & every other person or persons whatsoever the said Nathaniel Tatum & John Fort their heirs and assigns shall & will warrant & forever Defend by these presents In witness whereof the said Nathaniel Tatum & John Fort have put their hands & affixed their Seals this the day & date above mentioned
