 Williamson of the County of Southampton and State of North Carolina
 and Elizabeth his wife of the one part and John ^{Wilkinson} of the County
 of Southampton & State Virginia of the other part witnesseth that the said
 Stephen Williamson and Elizabeth his wife for and in consideration of
 the sum of two thousand ^{two hundred} pounds Current Money of Virginia to them in hand
^{paid} by the said John ^{Wilkinson} at or before the enrolling and delivery of these
 presents the receipt whereof he the said Stephen Williamson doth hereby acknow-
 ledge and thereof acquit and discharge the said John Wilkinson his heirs
 and assigns by these presents have and each of them hath granted bargain
 sold alien and release off and confirm and by these presents do grant
 bargain sell alien release off and confirm unto the said John Wilkinson and
 to his heirs and assigns all that Tract of Land lying and being in the County
 of Southampton and on the North side of a Herring River Containing by
 estimation one hundred and forty Acres to the same more or less and bounded
 as followeth to wit Beginning at the Bank of ^{river} anchoring in the County line thence
~~thence~~ along the County line to the Road adjoining the said Wilkinsons other Land
 thence along said Road to a white oak a corner thence along a line of Market
 trees to a pine in the quarter branch thence down the said Branch to the river
 thence down the said River to the beginning which was formerly granted to one
 Arthur Allen by Letters patent bearing date the Sixteenth day of June one
 thousand Seven hundred and twenty seven and by ^{divers} ~~many~~ means conveyance is since
^{vested} in the said Stephen Williamson party to these presents relation being there
